We are pleased to inform you that, effective January 1, 2025, the Hong Kong, China Automobile Association (HKAA) will continue its role as the governing body for karting under the CIK-FIA (Commission Internationale de Karting) delegation of sporting authority in Hong Kong, China.

In accordance with the International Sporting Code, the HKAA, as the ASN (National Sporting Authority), shall oversee the regulation and supervision of karting activities. This includes responsibilities such as licensing, event organization, safety and compliance, development and promotion, disciplinary actions and appeals handling. For all karting clubs in Hong Kong, the HKAA will provide regulatory oversight, race sanctioning, safety and compliance monitoring, dispute resolution, and development and support.

The HKAA is dedicated to advancing the sport of karting by encouraging participation and fostering community engagement. We look forward to collaborating with all stakeholders to promote a safe, fair, and exciting karting environment.

We welcome karting clubs, teams and individual participants to apply to HKAA for registration and/or for the issuance of National and International competition licenses for 2025.
